

**THE CORPORATION OF THE TOWNSHIP OF FRONTENAC

BY-LAW 029-2025

**BEING A BY-LAW TO ESTABLISH A FEES AND FARES
SCHEDULE FOR THE HOWE ISLAND FERRY OPERATION FOR
2026.**

WHEREAS Section 391 of the *Municipal Act, 2001*, S.O. 2001, c. 25 as amended authorizes a municipality to impose fees or charges on persons, for services or activities provided or done by or on behalf of it; for costs payable by it for services or activities provided or done by or on behalf of any other municipality or any local board; and for the use of its property including property under its control ;

AND WHEREAS The Corporation of Frontenac Islands operates a ferry to and from Howe Island known as the Howe Island Ferry;

AND WHEREAS the Council of the Township of Frontenac Islands deems it expedient to adopt the following fees and fares in relation to the Howe Island Ferry operation for the year 2026;

NOW THEREFORE, the Corporation of the Township of Frontenac Islands hereby enacts the following fees and fares structure in relation to the Howe Island Ferry operation for the year 2026.

1. Definitions:

- (i) *Single Vehicle*: Single vehicle will include a car, motorcycle, van, SUV, or pickup truck.
- (ii) *Heavy Vehicle*: Heavy vehicle will include any vehicle greater than 6,000 kgs and/or 7 metres (23 feet).

The 2025 pass shall provide access to both the County and Township operated ferries. A common fee structure shall apply for both the County and Township operated ferries.

Fees shall only be collected when vehicles are coming onto Howe Island from either the County or Township operated ferry.

The following fees shall apply for the year 2025:

| Ticket / Pass | 2026 Fee |

| One additional annual pass for a single vehicle in the same name | \$100.00 |
| Discounted additional annual pass for a single vehicle (65+) | \$270.00 |
| Discounted additional annual pass for a single vehicle in the same name | \$90.00 |
| Two-way trip for single vehicle | \$10.00 |

| Ticket / Pass | 2026 Fee |
|---|-----------------|
| Friends and Family Pass (10 two-way trips for a single vehicle) | \$75.00 |
| Two-way trip for single vehicle with trailer in tow | \$20.00 |
| Additional charges for annual pass holder with trailer in tow | \$10.00 |
| Tow-way trip for any heavy vehicle | \$20.00 |
| Replacement fee per annual pass | \$25.00 |
| Trailer pass (Island resident who has purchased annual pass) | \$300.00 |
| Cyclist | \$2.00 |

* These discounted fees apply to applicants who can show documentation indicating that they are 65 years of age or older during 2026.

** A second pass for \$100.00 will only be available if the second vehicle involved is registered to:

The same individual who purchased the first full-price 2026 annual pass. An individual who is married to or is in a common-law relationship with the full-price 2026 annual pass purchaser.

The dependent child under the age of 18 of a full-price 2026 annual pass purchaser or the full-price pass purchaser's married or common-law spouse.

The dependent child over the age of 18 of a full-price 2026 annual pass purchaser or the full-price pass purchaser's married or common-law spouse, only if the dependent child has both the same permanent address as the full-price 2026 annual pass purchaser and is attending school full-time.

Documentation must be provided that satisfies the staff person issuing the passes. A third pass in the same name will be charged at the full price.

A Memorandum of Understanding addressing the details of this arrangement has been executed to address the sharing of revenues between the Township and the County.


2. **THAT** this by-law shall come into force and take effect at the date of its final passing.
