Notice of Applications for Consent (Creation of a New Lot)

Take notice that the Council of The Corporation of the Township of Frontenac Islands is considering the following applications for consent to sever a new waterfront lot at 9:30 am on November 10, 2025 at the Wolfe Island Council Chambers (1191 Road 96) in Marysville and virtually through the Zoom platform, under the Planning Act, as amended.

Purpose and Effect of the Application: The property owner is proposing to sever a new waterfront lot for the purpose of donating the retained 9.78-hectare (24.17 acre) parcel to the Nature Conservancy of Canada.

Severed Lot Parcel: The proposed severed lot is 1.0 hectares (2.47 acres) in area with approximately 113 metres (370 feet) of frontage on Road 95. The severed parcel is developed with a dwelling and sewage system.

Retained Lot: The retained property will be 9.78 hectare (24.17 acre) in area with approximately 347 metres (1,138 feet) of frontage on Road 95. The retained parcel is vacant and adjacent to a Provincially Significant Wetland.

Additional Applications: Zoning By-law Amendment Z-03-25-W proposes to re-zone the retained 9.78-hectare (24.17 acre) parcel from Rural to Recreational Open Space (RE) to ensure it remains undeveloped.

If a specified person or other body that files an appeal of a decision of the Township of Frontenac Islands Council in respect of the proposed consent does not make written submissions to the Township of Frontenac Islands Council before it gives or refuses to give a provisional consent, the Ontario Land Tribunal may dismiss the appeal.
